Dear Comrades,

Observe BSNLEU Day on 22nd March, 2011

BSNLEU's foundation day falls on 22nd March, 2011. This is the tenth anniversary of BSNLEU's foundation. These ten years are eventful and are undoubtedly glorious. Government started BSNL, with the intention to privatize it. But even after ten years, government was unable to achieve its goal, mainly because of the struggles that have taken place against disinvestment/IPO. No doubt, BSNLEU has stood in the forefront in uniting all the trade unions against the moves of the government to privatize BSNL. It has taken initiative for massive struggles which have pushed the government to the back foot on this issue. During these ten years BSNLEU has settled many demands of the employees including an excellent 'Wage Revision' and a promotion policy which has benefited the employees in a big way. Because of all these achievements, BSNLEU has got elected four times with massive support in the elections for union recognition. Thus, the tenth anniversary of BSNLEU's foundation deserves to be celebrated with all enthusiasm. Circle and District Unions are called upon to celebrate BSNLEU's Foundation Day in a big way. Special meetings shall be organized and BSNLEU's achievements shall be explained. Simultaneously, social activities like blood donation camps, helping poor school children etc. can also be organized. Strengthen the Organisation - Conduct regular General Body meetings.

BSNLEU has to be strengthened for protecting and strengthening BSNL. It is because, BSNLEU is the organization which spear heads the struggles against the government's policies which harm BSNL. Ensuring democratic functioning is very important to strengthen BSNLEU. Holding of regular General Body meetings every month at the Branch level is very essential to strengthen democratic functioning. That is why the Thiruvananthapuram All India Conference as well as the Nagpur Extended Central Executive Committee has emphasized the conducting of Branch General Body meetings every month. However, CHQ feels sorry to note that much improvement in this regard has not come. Circle and District Secretaries are requested to pay sufficient attention to this issue. This issue shall be regularly reviewed in the Circle and District Executive Committee meetings.

Nominations for Circle and Local Councils.

CHQ is approving the nominations for Circle and Local Councils, as and when the proposals are received. As per the decision of the National Steering Committee, nominations should be sent to the CHQ, only after they are duly approved in the District and the Circle Steering Committees. In case no alliance partners are available in a Circle/District, the same should be clearly mentioned while sending nominations to the CHQ. Circle and District Secretaries are requested to strictly implement the agreement made with the alliance partners, regarding seat sharing.

Building Fund.

Collection of CHQ Building Fund has been some what slowed down due to the 5th membership verification process. Now that the verification is over, Circle and District Secretaries are requested to take immediate steps to fulfill their quota for Building Fund. CHQ intends to purchase the building in the month of May. Hence, all are requested to hurry up with the collection of donation, so that our dream will be fulfilled.

CEC meeting at Chennai.

The Central Executive Committee meeting of BSNLEU is taking place at Chennai from 22nd to 24th March, 2011. This meeting coincides with the 10th anniversary of BSNLEU's foundation. The CEC will review the 5th membership verification and will also chalk out the future course of action.
