## ***March to Parliament and 3 day strike - make it a grand success***

It is hoped that the District and Circle Unions are making all out efforts for making the 3 day strike and the March to the Parliament a grand success. As already informed, the dates of both the programme have been changed. The rescheduling of the dates are due to unavoidable reasons. Due to the visit of the US President, the March to the Parliament will take place on 15<sup>th</sup> November, 2010. Similarly, in view of the counting of votes of the Bihar Assembly elections, the dates of the three day strike are rescheduled to 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> December, 2010.

CHQ requests the circle unions of UP (West), UP (East), Haryana, Rajasthan, Punjab, NTR, Himachal Pradesh and Uttaranchal to make maximum mobilization for the March to the Parliament. Other circles are also requested to send as many comrades as possible.

Circle and District Unions have to start making fullest preparation for the three day strike. Together with other constituents of the JAC, special meetings have to be conducted at the District and Branch levels. Those circles which have not conducted the circle level JAC seminar have to complete the same within the 3<sup>rd</sup> week of November.

## ***Bonus / PLI issue – observe dharna on 28.10.2010***

General Secretaries of the JAC constituents have observed one day fast at the BSNL Corporate Office on 15.10.2010. After the CMD returned from his foreign tour, BSNLEU representatives met him on 25.10.2010 and demanded immediate payment of bonus / PLI. But his reply was in the negative and our demand was not accepted. Hence, organize dharna on 28.10.2010 with full vigour, together with other constituents of JAC.

## ***Building fund***

After the Extended CEC meeting held at Nagpur, there is a slow down in the collection of the building fund. Circle and District unions have to immediately gear up the collection. It may be kept in mind that still we have to go a long way to achieve the quota of Rs.3 crore. If each and every District Secretary does not cooperate, it will be very difficult to purchase our own union building at Delhi.

## ***NFTE BSNL files case against 5<sup>th</sup> Verification***

NFTE BSNL has filed two writ petitions in Madras High Court against the 5<sup>th</sup> membership verification. They have demanded that the 5<sup>th</sup> verification should be stayed and the Code of Discipline should be amended so as to give recognition to the 2<sup>nd</sup> union also. BSNLEU has engaged a senior advocate to argue it's case. We hope that the road-blocks will be cleared and that the 5<sup>th</sup> verification will take place as per schedule.
