Agreement signed for purchasing union building at New Delhi

The agreement for purchasing a building, located in West Patel Nagar, was signed on 05.10.2011. The price of the building is Rs.2.90 crore. An amount of Rs.1 crore is paid as advance. As per the agreement, the last date for paying the balance amount is 05.12.2011. Apart from paying the price of the building, we have to spend sizeable amount for registration also.

All the comrades at the Central Head Quarters have contributed for this great achievement. I wish to place on record, that apart from myself, Com. V.A.N. Namboodiri, President, Com. P. Asokababu, Dy. GS, Com. S.C. Bhattacharjee, Treasurer, Com. R.S. Chouhan, Organising Secretary, Com. G.B. Salakki, AGS, and Com. Swapan Chakraborty, AGS, have done great work in identifying the building, making the bargaining, making legal verifications, etc.


