Sub: **Absorption of Group 'A' officers in MTNL/BSNL – Calling of option regarding**

Ref: **This office letter of even number dated 28th August, 2008**

While monitoring the progress made on implementation of DOT letters dated 26.8.2008 relating to absorption of Group 'A' officers in BSNL/MTNL, a doubt was raised on Para (3) of DOT earlier letter dated 4.10.2005, which provided that officers who didn't opt earlier (including given conditional option) shall be deemed to have opted for Government service.

2. As per Para 2 of DOT letter dated 26.8.2008, option for absorption in MTNL/BSNL has been called from all serving & those who have retired since 1.10.2000 Group 'A' officers, who were on the regular establishment and were transferred to MTNL/BSNL on deemed deputation basis and who were on the rolls of DOT/DTS/DTO as on 30.9.2000. This, however, excludes those Group 'A' officers, who have already been absorbed in MTNL/BSNL. Therefore, it is clarified that the officers who didn't exercise option earlier or submitted a conditional option in response to DOT letter dated 4.10.2005 would be eligible to exercise option as of now.

3. Further, for the purpose of seeking option, a draft letter proposed to be issued to each individual Group 'A' officer, as per DOT letter dated 26.8.2008, is sent herewith for further necessary action.

4. It is requested that further necessary action may please be taken as per the time schedule stipulated by the DOT.
